Target Market Summary

This product is likely to be appropriate for a consumer seeking Capital Growth and some Income Distributions to be used as a Satellite / smaller allocation or a Core Component not exceeding 50% allocation within a portfolio where the consumer has a Long investment timeframe, High risk/return profile and needs access to capital paid within 10 days under ordinary circumstances.

Investment products and diversification

For example, a consumer may seek to construct a conservative portfolio with a satellite/small allocation to growth assets. Review triggers and Distributor Reporting	
Significant Dealings	<p>Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Section 994G of the Act requires the Issuer to notify ASIC if it becomes aware of a significant dealing in the Fund that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is ‘significant’ and distributors and the Issuer have discretion to apply its ordinary meaning.
